### Terms and Conditions

- A \$50.00 fee will be assessed for a drop or change of meal plan as of the first day of the semester (September 5, 2006 and January 16, 2007). A drop or change of a dining plan will not be accepted after the second Friday of each semester (September 15, 2006 and January 26, 2007). Charges will be prorated during this period. A Dining Service Change Form must be completed with the Bursar.
- When dropping a meal plan, any remaining meal plan points are forfeited.
- All first year students living on campus are REQUIRED to join either the Unlimited Plan, the A Plan, or the B Plan.
- All Barnard or Columbia students residing in the Quad Residential Area [except Sulzberger Tower] are required to select from the Unlimited Plan, Plan A, B or C.
- Any remaining meals at the end of the semester are forfeited. Any meal plan points remaining at the end of the Fall semester may be carried over to the Spring semester providing the student remains enrolled in a Barnard meal plan during the Spring semester. Any meals or meal plan points remaining at the end of the Spring semester are forfeited.
- I understand that by signing this contract, I am authorizing the college to enroll me in the meal plan specified above. I agree to be liable for the plan unless I cancel it in writing on the Barnard College Dining Services Change Form prior to the start of the semester. If I do not cancel it prior to the semester and if I default on my payment, the College may disclose that I have defaulted, along with relevant information, to credit reporting agencies. I understand that the College reports delinquent accounts to a collection agency. I agree to pay any costs of collection including, without limitation, interest, penalties, collection agency costs, court costs, and attorney fees. Collection costs can be up to 50%. This agreement applies to any and all amounts due to the College now and in the future.
