### Instructions

To be considered for a grant, your parents must submit: 1) a completed Grant Application Form 2) a signed copy of the parents' and students' 2007 federal income tax (including all pages and schedules) and 3) all applicable W-2(s) along with your application for admission to the Pre-College Program. Forward your completed applications to: Director of Pre-College Programs, Barnard College, 3009 Broadway, New York, New York 10027-6598. Applications must be postmarked no later than April 18, 2008. Income information will be kept confidential and will be used solely to determine need for grant aid in the Pre College Program. Keep a copy of the application for your records.

If your natural parents are separated or divorced, both the custodial and non-custodial parent are required to submit proof of income to apply for assistance. Information can be sent in separate envelopes addressed to the Pre-College Office. Each parent must submit items 1-3 mentioned above. The custodial parent is the parent with whom the student resides. If either parent has remarried, the income from the new family unit must be reported on the application. This is because the income and assets of the entire new family unit is considered pertinent to the natural parents' ability to contribute to the cost of the program.

Students will be notified of their award status in mid-May. All students who plan to attend the program will be required to submit a \$300 non-refundable deposit within two weeks of learning their grant award status. Please refer to the brochure for further information about program fees and charges.
