### Harvard

I like to think that I have a pretty good handle on the various residential fellowship opportunities open to faculty, but every once in a while, I'll be looking for a field-specific opportunity and stumble across a new option. Almost without fail, the visiting faculty fellowship is for some center at Harvard. I've already talked plenty about the history of Harvard, both in this column from [The History of American Philanthropy](#) and in a profile on [Radcliffe's Institute for Advanced Studies](#). So let's jump into options!

[I Tatti: The Harvard University Center for Italian Renaissance Studies](#): "Each semester, several distinguished senior scholars serve as Visiting Professors. [...] In addition to housing on the I Tatti property and funds to cover their airfare and utilities, Visiting Professors are offered lunch and tea on weekdays, provided a study in the main Villa, given access to the Biblioteca Berenson seven days a week, and encouraged to participate in all aspects of the intellectual life of the Center, including site visits, conferences, and seminars."

[The Ash Center for Democratic Governance and Innovation](#) invites... scholars who use approaches from political theory and philosophy, political science, sociology, law, or history. We are especially interested in drawing scholars whose work focuses on innovations in public participation and political participation in democracies or non-democracies." **Deadline:** December 1, 2022. **Funding:** N/A. Provides use of space and resources.

[The Edmond J. Safra Center for Ethics at Harvard University](#) invites applications from a broad range of researchers and practitioners who will work over the course of the year on pressing issues in ethics. Faculty in arts and sciences and professional schools, postdoctoral scholars, practitioners, and researchers from industry, government, and NGOs are eligible to apply. For the 2023-24 academic year, the Edmond J. Safra Center for Ethics will continue its focus on the theme of 'A New Social Compact?'" **Deadline:** November 15, 2022. **Funding:** \$75k and \$3k for research funds.

[The Belfer Center for Science and International Affairs](#) offers research fellowships during the academic year to individuals who wish to devote their time to research and writing in the fields of science and international affairs." **Deadline:** **Funding:** Varies.

[The Warren Center](#)... has annually hosted 6-12 visiting scholars... at a critical point in their scholarship ... Starting in 1995, the fellowship has carried an annual theme, drawing the fellows into even closer connection by virtue of shared interests, and expanding the Center's reach as the themes have grown increasingly interdisciplinary....The 2022-23 Warren Center Faculty Fellowship will be on the theme of Capitalism's Hardwiring: Money, Credit, and Finance in a Globalizing World, 1620-2020 led by Chris Desan (Harvard Law) and Kenneth Mack (Harvard Law). [W. E. B. Du Bois Institute for African and African American Research](#)... annually appoint[s] scholars who conduct research for an academic year or for one semester in a range of fields related to African and African American Studies ... Fellowship projects have encompassed art and art history, Afro-Latin American studies, design and the history of design, education, hiphop, African and African diaspora studies, African American studies, Indian Ocean studies, literary studies, and creative writing." **Deadline:** January 23, 2023. **Funding:** variable.

[The Harvard University Center for Jewish Studies](#) invites applications each academic year for the Harry Starr Fellowship in Judaica. Applicants may come from any discipline in the humanities or social sciences associated with studies in Judaica; junior faculty are especially encouraged to apply." **Funding:** TBA. Previously January 24, 2022. **Funding:** \$40k-60k.

## Sage Advice

### Why You Should Apply for Fellowships, Even if You Are Already Funded

I don't need to tell you that Barnard faculty are exceptionally lucky to receive a fully funded SAPL year to pursue research after their third-year review. But that does tend to raise a question we hear half-voiced from time to time: Why apply for fellowships at all, if SAPL is fully funded?

It's a good question. Fellowship applications are a lot of work, so why go through the effort if you're already set with time and money? In no particular order, here are a few thoughts.

1. Writing fellowship applications forces you to clarify to yourself what your project is and why it matters in big picture terms. This is especially helpful if you are writing a book and want to start thinking about your potential audience beyond your immediate field, since most of the big fellowships, like the ACLS, usually are reviewed by specialists in your field as well as by those outside your field. 2. Fellowship applications force you to think about the structure of your project, if you're starting a new project. An application is a great opportunity to ask yourself how many chapters you imagine your book being, what themes you want to focus on, or what objects you want to center your analysis on.
3. It's a good way to get feedback on your project. Especially if you are proposing a project that you are just starting, reviewers can let you know if there are any big holes in your project, any components that are likely to be misread, or any issues you want to head off.
4. Taking the time to develop a succinct, compelling description of your project will be helpful when it comes time to write a book proposal.
5. Fellowships might help you make connections. This is particularly true if you get a residential fellowship, such as at the Institute for Advanced Studies.
6. Fellowships help pay for travel expenses. If you want to go to archives elsewhere in the country or abroad, view particular artworks, consult with other scholars, or, frankly, find someone to pay you to hang out in Paris for a year, fellowships can help.
7. It helps your tenure case. A fellowship is one more data point that you are taken seriously as a scholar within your field.
8. Fellowships also look good on other fellowship applications. The Guggenheim, for example, asks you to list all of your previous awards in your Career Narrative. I know this one is a little depressing, but as you can see in the [News Story](#) about how reviewers award higher marks to famous authors, the Halo Effect is real, alas.
9. You will probably want to apply for fellowships eventually. Even if you don't need the money right now, once you get tenure, the sabbatical policy at Barnard offers you "one year at half-salary or a half-year at full salary," which means that if you want a full year at full pay, you will need to bring in fellowship funding. So why not practice writing fellowships now, when there is less at stake financially?
10. Done right, fellowships can renew your interest in your work. Fellowship applications are a chance to reconnect with what was initially exciting about your work and to share that information with readers.

## The History of American Philanthropy

In the last few issues, we've profiled a few different community foundations, not because I have any hopes of definitively telling you what philanthropy meant to [Jewish-American](#), [Chinese-American](#), or [Cherokee communities](#) in the mid-nineteenth century, but because a lot of the really big foundations we still live with today began with the impulse to "fix" the patchwork of local charities and it seemed only fair to give a sense of what those organizations meant for the communities they represented. But there was another big social issue in play in the years leading up to the first big foundations: Reconstruction. It's a complicated story, so we're going to spend at least a few issues on it.

It hardly needs to be said that the Civil War devastated the Southern economy. [2.5% of the population died in the war, with Confederate soldiers dying at a rate of 3:1 compared to Union soldiers. 40% of all the people who died in the Civil War were never identified, while 66% of the dead African American Union soldiers were never identified.](#) Men had gone out to fight and never come back. The plantation economy had rested on slavery, now slavery was over. And of course, there was the very real question of how to help economically the nearly [4,000,000](#) formerly enslaved now that they were free—*especially* given that they were now free surrounded by largely hostile white populations.

[The Freedmen's Bureau](#) helped with the last problem, at least for a little while. We'll talk more about the Freedmen's Bureau in the next issue, but suffice to say that it didn't last long and didn't do much to help another issue that the Northern philanthropists watched with unease—white poverty. And that's really the starting point of the Peabody Education Fund, sometimes called the first modern foundation.

Peabody was a reference to [George Peabody](#), a wealthy American merchant born in 1795 in South Danvers (now Peabody) Massachusetts. George Peabody was one of seven children and grew up in relative poverty with little formal education, something he lamented in later years. He volunteered for the War of 1812 and while there met Elisha Riggs, the son of a silversmith, who later provided the financial backing for a dry goods business named Riggs & Peabody. The business flourished and Peabody spent twenty years working alongside Riggs, building a merchant empire based in Baltimore. In 1827, business took him to England, where he eventually settled after Riggs retired.

His business turned from dry goods to banking and starting in the 1830s he sold railroad securities alongside state and federal bonds to English investors. At times, the business was unstable. In the 1840s, Maryland defaulted on its international debts and Peabody was briefly banned from all his local London dining clubs. Through careful propaganda and bribery, he persuaded the states to resume payment. The scheme boosted more than his social standing; he had bought a large number of state bonds when they were nearly worthless and as soon as payments resumed, he made a fortune.

Long after he became fabulously wealthy, Peabody was legendary for his thriftiness, not to say miserliness. According to one story, his sole daily indulgence was to purchase an apple every day to go along with his packed lunch. [Another popular story](#) revolves around his refusal to buy a personal carriage.

"Once, when he was sick, Peabody was convinced by his partner to leave early. The man later found him standing in the rain at the station. After inquiring as to why he was still around, Peabody said 'there's only been a two-penny bus that has come along as yet. I'm waiting for the penny one.'"

I have to say, packing your lunch and using public transit seems less like a sign of pathological miserliness to me than a typical Tuesday, but [the very rich are different from you and me.](#)

His frugality meant that he had a very great fortune at hand when he decided to start giving it away. The strange thing is that he didn't *mean* for his fortune to benefit primarily white students—on the contrary, it was supposed to benefit all students equally. How it became a prop for white students at the expense of Black students is a question for our next issue.

### Reminders About Financial Conflicts of Interest and Other Support

“A recent [study from the HHS Office of Inspector General](#) (OIG) affirmed that NIH grant recipients play a key role in protecting the integrity and security of U.S. biomedical research, in part through requiring Investigators to disclose all of their significant financial interests and all sources of their other support. As noted by the OIG, failures by some recipients to disclose substantial contributions of resources from foreign entities (including foreign governments) have raised concerns about threats to the integrity of NIH-supported research. In response to the OIG recommendations, we are reminding grant applicants and recipients again today of NIH’s [Financial Conflict of Interest \(FCOI\)](#) and [Other Support](#) grant requirements.

“Today we released [NOT-OD-22-210](#) that provides important reminders about the FCOI regulation and Other Support policy requirements. We encourage all those involved in the NIH grants process to review this information carefully to ensure compliance.” [<<more>>](#)

### Ford Foundation Ends Fellowship Program

### Who’ll Pay for Public Access to Federally Funded Research?

“The status quo for the last decade in publishing the results of federally funded research—sequestering it behind a paywall for up to one year—was from the beginning a compromise that fully satisfied no one. It created modest changes in publishers’ business models but also prevented scientists and citizens from accessing the most recent developments advancing environmental justice, cancer research, clean energy technologies and more.

“The U.S. government acknowledged as much in August when it announced a [new policy](#) for free, immediate public access to federally funded studies, scheduled to take effect by 2026. Open-access advocates celebrated the news, while others, including the Association of American Publishers, [expressed](#) concern about the economic impact on members. But details concerning how much the new policy would cost and who would pay were left for another day.” [<<more>>](#)

### Not Just Chips

“The [CHIPS and Science Act](#), which was signed into law by President Biden Aug. 9, opens transformational and once-in-a-generation opportunities for a diverse array of institutions. While the scale of new funding opportunities for universities is seismic—more on that in a moment—the act’s impact will go far beyond the [Association of American Universities](#) and other [R-1](#) (very high research activity) institutions. Beyond the research mission, the law also authorizes funding for STEM-related higher education and workforce development at levels that are unprecedented since the early days of the Space Race during the 1950s and 1960s. This funding stands to benefit smaller, regional institutions,

those that are most likely to be struggling against complex headwinds since the onset of the pandemic. Moreover, many of the act's provisions are designed to ensure that some funding is routed to historically Black colleges and universities, minority-serving institutions, community colleges, and institutions in states that historically have not benefited from this type of federal support." ### White House Releases Disclosure Template for Grant Applications

### MIT professor wrongfully accused of spying for China helps make a major discovery

"Months after an MIT professor was cleared of spying for China, he helped make a major scientific discovery. But he says the success has been bittersweet.

"Gang Chen, who had espionage charges against him dismissed in January, was part of a research effort that last month discovered what could be the "best semiconductor material ever found," the school announced. But Chen told NBC Asian America that after undergoing a lengthy Department of Justice investigation, he is stepping away from federally funded research, despite the discovery, because of anxieties around being racially profiled." ### Reviewers award higher marks when a paper's author is famous

"Yes, having a big name in science will help get your paper published, an unusually robust new study confirms. Just 10% of reviewers of a test paper recommended acceptance when the sole

listed author was obscure—but 59% endorsed the same manuscript when it carried the name of a Nobel laureate.

The study, which involved recruiting hundreds of researchers to review an economics manuscript, is “incredible,” says Mario Malic’ki, a postdoctoral researcher at Stanford University and editor-in-chief of Research Integrity and Peer Review, who was not involved in the research. “It is the largest randomized controlled trial we have seen on publication bias.” [<<more>>](#)

### **Just a small rise in Earth’s temperature could cause irreversible ecosystem and weather changes**

“From melting ice sheets to stressed coral reefs, global warming is changing our world in unmistakable ways. But identifying “tipping points,” thresholds past which such transformations become irreversible or self-sustaining, has been more difficult—and controversial. Some researchers argue that emphasizing looming but uncertain points of no return could feed public apathy, rather than energize efforts to curb climate change.

“An **expansive study of climate tipping points** in this week’s issue *Science* is likely to fuel that discussion. It synthesizes the most current evidence on how much warming would risk passing 16 tipping points, triggering polar ice collapses, permafrost thawing, monsoon disruptions, and forest and coral reef diebacks. Many of these systems are already stressed by rising temperatures, and the study finds the world might already be within the warming range where the risk is elevated. It also concludes that even under the most ambitious scenario for limiting global warming—to 1.5°C compared with preindustrial levels—the planet could still see dramatic changes.” [<<more>>](#)

### **American Association of University Women Postdoctoral Research Leave Fellowships**

"The primary purpose of the American Postdoctoral Research Leave Fellowship is to increase the number of women in tenure-track faculty positions and to promote equity for women in higher education. This fellowship is designed to assist the candidate in obtaining tenure and further promotions by enabling them to spend a year pursuing independent research. Tenured professors are not eligible. ### **American Association of University Women Summer/Short-Term Publication Grants**

"The Short-Term Research Publication Grants provide support to scholars to prepare research manuscripts for publication. Preference will be given to applicants whose work supports the vision of AAUW: to break through educational and economic barriers so that all women have a fair chance. Time must be available for eight

consecutive weeks of final writing and editing in response to issues raised in critical reviews. These fellowships can be awarded to both tenure-track and part-time faculty, and to new and established researchers. The fellowships are designed to assist the candidate in obtaining tenure and other promotions. Tenured professors are not eligible. Open to applicants in all fields of study. Scholars engaged in science, technology, engineering and math fields or those researching gender issues are especially encouraged to apply." [link](#)
