Featured Funders

Columbia's 2023 Office of the Provost's Teaching and Learning Grants

[We have talked before](#) about the various grant opportunities available to Barnard faculty at Columbia, but in today's Featured Funder issue, I want to focus on a particular set of opportunities located in the Provost's Office and focused on pedagogy.

"The Office of the Provost provides funding opportunities for faculty looking to integrate new educational methods and technologies into their classes and learning environments. This request for proposals seeks innovative projects to design course modules, entire courses, or massive open online courses (MOOCs) and supports teaching initiatives at the department, program, or school level. Proposals from all disciplines and subject areas are welcome, and awardees will develop projects over the next academic year.

"This year, the Office of the Provost has allocated **additional funding** to encourage faculty to innovate and experiment pedagogically with generative Artificial Intelligence (AI) tools (e.g. ChatGPT) in courses or curricula. Faculty are encouraged to consider how AI tools can be leveraged to enhance teaching and learning in all of the grant options included below. Other than an idea for pedagogical innovation, such as incorporating AI tools into assignment design, assessment practices, or classroom policies, there are no additional requirements to request a consultation with the CTL to discuss a potential project."

There are currently seven different opportunities, listed below. Please note that all grantees are expected to collaborate with Columbia's Center for Teach and Learning. In-kind support is part of the grant. **The deadline for all submissions is May 1, 2023.**

"Innovative Course Design (full course; new or existing): increase teaching effectiveness and student engagement through the creative use of new pedagogical strategies and/or digital tools; the use of technologies to create evergreen resources for foundational course." Funding: up to \$20,000.

"Innovative Course Module Design: support experimentation with a new pedagogical strategy or tool (not a full course redesign)." Funding: up to \$2,000.

"Interdisciplinary Teaching Initiatives (ITIs): support teams of 2-4 faculty from different disciplines/ departments/schools to work collaboratively on the design and launch of innovative teaching initiatives that will benefit undergraduate or graduate learners across two or more departments and/ or schools." Funding: Up to \$20,000.

"Large-Scale for Departments, Programs, or Schools: support large-scale, coordinated efforts around teaching initiatives in a department, program, or school; the use of technologies to create evergreen resources for foundational courses." Funding: Up to \$20,000.

"Massive Open Online Courses (MOOCs): reach global audiences, make more visible the teaching and research activities of the University while promoting public engagement." Funding: Up to \$25,000.

"Emerging Technology Grant: support experimentation with new pedagogical strategies using extended reality technologies (augmented/virtual reality, 3D scanning/printing)." Funding: Up to \$20,000.

"SOLER Seed Grant: conduct formal research to address questions about teaching and learning in a disciplinary context." Funding: Up to \$5,000.

Sage Advice

In Praise of Formatting

So you have a project, you've perfected your elevator pitch, you can explain why it matters, what you've already done, why you're the best person to do it, and what, exactly, you plan on doing with the money. But there's one thing more to think about before you submit, if you really want your proposal to stand out—formatting.

I really mean this in two different senses. There's the issue of meeting the funder's explicit guidelines around formatting. That can usually be solved readily enough by reading the call closely and asking yourself questions like the following.

- Does the funder have preferred fonts, like Times New Roman or Arial?
- Is there a minimum font size?
- Are there required margins?
- Are there any rules about hyperlinks? (Some funders will see linking to further material as a way to sneak in extra information.)
- Are there any specific requirements for the PI's CV? (Think, inclusive dates, locations, etc.)

All of that matters and if you send your proposal to us, we can help check that you didn't accidentally skip anything. **But there are also guidelines about content and I want to make a pitch for formatting your proposal to make it absolutely clear to your reviewer (and to yourself!) that you're meeting them.**

The easiest way to do so is section headings. Is the rfp asking you for a brief literature review? Create a subheading called "Literature Review" and put it in bold or italics for good measure. Do they want a timeline? Consider creating a bulleted list or a chart that makes explicit what you want to accomplish when. Is there one sentence that makes it absolutely clear what your project aims to accomplish? Consider putting it in bold.

People applying to the NSF or NIH tend to do this naturally, helped by the fact that the proposals are relatively long. Of course you create subheadings in 12 pages of narrative; it would be unreadable otherwise. It can feel tempting to skip formatting if you have a much shorter proposal, though. If you only have two pages, do you really want to waste space on subheadings?

I would argue yes.

Reviewing is hard.

Reviewing is exhausting.

Reviewers are often cranky and can find themselves looking for mistakes.

Reviewers can also be bad readers.

A reviewer might still do a terrible job reading your proposal, but giving visual cues makes it less likely they'll accuse you of skipping altogether the section on impact or dissemination. It also makes it less likely that you'll accidentally skip a part of the proposal.

So next time you're about to turn in a grant and see a block of uninterrupted text, consider breaking it up to make it that much easier for a reviewer to check off boxes in a rubric. It might feel hokey and it might not be great literary writing, but it's effective grant writing.

The History of American Philanthropy

When Russell Sage died in 1906, Olivia Slocum Sage inherited nearly all his money and became one of the wealthiest women in the world. How wealthy? It's hard to say, exactly. [A 2014 article from CNN](#) pegs Russell Sage's fortune at \$53.6 billion in today's money and estimates that he would have been the eighteenth richest American who ever lived. To give some context, MacKenzie Scott received something on the order of \$36 billion in her divorce settlement from Jeff Bezos (though found her fortune climbing faster than she could give it away and by some accounts even reached [\\$53 billion](#).) So how rich was Olivia Sage? Peak MacKenzie Scott rich, if not richer.

Much like MacKenzie Scott, Olivia Sage immediately set about giving her fortune away. [Some of her funding went to educational institutions](#), especially Syracuse University, Cornell, and Princeton, in addition to a founding grant for Russell Sage College. But she's best known for giving \$10 million (in the currency of her time) to launch the Russell Sage Foundation for "the improvement of social and living conditions in the United States." [In her letter establishing the foundation](#), Slocum Sage insisted that "the scope of the Foundation is not only national but is broad. It should, however, preferably not undertake to do that which is now being done or is likely to be effectively done by other individuals or by other agencies. It should be its aim to take up the larger and more difficult problems, and to take them up so far as possible in such a manner as to secure co-operation and aid in their solution."

[Many months ago, we discussed the rise of scientific philanthropy](#)—that is, the idea popular in the latter half of the nineteenth century that charity was too regional and too patchwork in the United States and needed to be replaced by philanthropic efforts that pulled up the root causes of poverty. Olivia Slocum Sage's letter was an expression of that sentiment and with the Russell Sage Foundation, she was able to launch a trial of that philosophy in a big way.

Practically speaking, this means that the Russell Sage Foundation funded a number of innovative surveys and experimental projects. To give a few examples, in 1907 it funded "The Pittsburgh Survey," a landmark study into working conditions of the urban poor in Pittsburgh. The survey had over seventy investigators, was published both in magazines and as standalone volumes, and helped, in time, lead to a number of Progressive laws, such as the end of twelve-hour work days and seven-day weeks for steelworkers. Other studies followed, covering topics such as housing, working conditions, education, consumer credit, and workplace health and safety.

The Foundation also made less successful experiments. [As its website notes](#), between 1909-1922:

RSF expends nearly a sixth of its capital to build Forest Hills Gardens, a model suburban community for working families designed by architect Fredrick Law Olmstead. The grand aim was to demonstrate the possibilities of intelligent town planning for moderate cost housing close to a major urban center. The architecture was a great success, but the housing prices soon soared beyond the range of the families they were intended for, and the Foundation lost a significant part of its investment.

By the time Olivia Slocum Sage died in 1918, she had given away \$45 million by some estimates. She only ever published one piece explaining her life and philosophy, a short article called "Opportunities and Responsibilities of Leisured Women." It begins by stating, "There is an immense amount of feminine talent and energy wasted in the world every day. This is not due to the indifference or the laziness of woman, for she is eager to do, to accomplish, to go out into the field of life and achieve for herself and for her kind. But she simply does not know how."

I want to leave the discussion of her article here, to be picked up next issue as part of a deeper into the role of women in early philanthropic reform.

“NSF 2022 Research Security Training for the United States Research Community awardees announced”

“The U.S. National Science Foundation announced four awards under the [Research Security Training for the United States Research Community](#) program. The program is a cornerstone of the NSF mandate to strengthen research security in the U.S. while encouraging principled international collaboration. NSF has long worked in partnership with federal agencies that fund research to improve the development and implementation of research security. In addition to NSF, the research security training module series is also supported by funding from the National Institutes of Health, the Department of Energy, and the Department of Defense.

“Awardees will receive financial support to establish research security training frameworks that address U.S.-funded research and development security concerns, risks and threats. The four awardees will focus on developing training modules that detail research security insights and best practices, address the importance of disclosure, identify and remedy knowledge gaps in risk management and mitigation, and provide training on principled international collaboration.” [<<more>>](#)

Advancing the Promise of Open Science: We Want to Hear from You!

“Today, we are pleased to announce that the [“NIH Plan to Enhance Public Access to the Results of NIH-Supported Research”](#) (NIH’s Public Access Plan) is now available for public review and

comment. We are issuing this Plan in response to the OSTP memo and also because it is consistent with NIH’s longstanding commitment to open science. This Plan builds upon the strong foundation of the [NIH Public Access Policy](#) which, since 2008, has made over 1.4 million articles describing NIH-supported research available to the public through [PubMed Central](#). As you will see, the Plan builds on what we currently do, and we expect to maintain many current practices. But importantly, we ultimately plan to institute a zero-embargo period on publications so that research results are freely available to the public without delay.” [<<more>>](#)

Recommendations for Proactively Addressing Authorship Disputes

“Generally speaking, we do not handle authorship disputes as possible research misconduct violations. The HHS Office of Research Integrity will **not handle** these types of disputes either. Rather, authorship disputes among research collaborators must be addressed internally at their institution and/or lab. In some cases, it becomes apparent that an authorship dispute reflects deeper workplace environment problems, which may include harassment and/or discrimination.

“We receive around a dozen of these complaints each year. Although we do not handle them directly as possible research misconduct, we would like to offer some informal advice for researchers and institutions to consider. These include:

- Institutions, departments, or large multi-site research groups could establish publication committees. These committees would allow information and rules regarding all matters related to authorship to be laid out and negotiated in advance. The committees could also address issues that come up due to changing circumstances once a project is under way (e.g., one of the project members

drops out).

- Individual labs can write and disseminate their own authorship policies and procedures. You could consider also including these in a [lab manual](#). These policies could be revisited over time as personnel and circumstances change.
- Most journals already require that the corresponding author attest that the other authors are in agreement with the entire content of the paper. A manuscript should only be submitted if everybody agrees. Institutions could set up policies and procedures to assure that all researchers understand and abide by this requirement.” [<<more>>](#)

Share Your Thoughts on How to Re-envision NIH Supported Postdoctoral Training

“In November 2022, NIH announced the creation of a new Working Group (WG) to the Advisory Committee to the Director (ACD) on [re-envisioning NIH-supported post-doctoral training](#). The most recent concerns surrounding post-doctoral (“post-doc”) training involve numbers, including the numbers of post-docs and the number of available tenure-track faculty positions. [Recent data from NSF](#) suggest a substantial decline in post-doc numbers, coming at a time of pandemic stresses, global economic disruptions, and concerns surrounding salary, stipend, and benefit support [...]

In an effort to engage internal and external stakeholders, the WG is requesting your response to this [Request for Information \(RFI\)](#). We are asking you for input on:

- Perspectives on the roles and responsibilities of the academic postdoc.
- Fundamental issues and challenges inhibiting recruitment, retention and overall quality of life of postdoctoral trainees in academic research.

- Existing NIH [policies](#), [programs](#), or [resources](#) that could be modified, expanded, or improved
- Proven or promising external resources or approaches that could inform NIH’s efforts to improve the postdoctoral training ecosystem.

U.S. scientists brace for tighter scrutiny of potentially risky research

“Federally funded scientists who work with potentially harmful bacteria, viruses, and other agents could soon face a major expansion of U.S. government oversight. An expert group last week recommended broadening rules that require universities and funding agencies to determine whether proposed studies count as dual-use research—work that carries the risk of intentionally or accidentally creating a bioweapon. Currently, such reviews are only required for experiments involving 15 dangerous agents. But the panel argues the reviews should now extend to work with all human, plant, and animal pathogens, even those causing only mild disease.” [<<more>>](#)

Postdocs need raises. But who will foot the bill?

“Postdocs—the Ph.D.s who do much of the labor of science—are notoriously underpaid. But the problem has intensified over the past year as postdocs struggle to get by amid soaring inflation and professors **report problems recruiting Ph.D. graduates** to fill positions. Several institutions and states have recently implemented policies to increase their pay. But these policies haven’t always come with an increase in funding, leaving lab leaders wondering how to cover rising staff costs and what the downstream effects will be. “I think a lot of faculty feel extremely trapped,” one professor says.

“This is much needed change; postdocs are simply not paid enough,” says Kelly Stevens, an associate professor of bioengineering at the University of Washington, Seattle. In that state, a law went into effect this month stipulating that organizations with 51 or more employees must pay salaried employees at least \$65,478 per year; the National

Institutes of Health (NIH) starting postdoc salary, which many institutions use as a baseline to set their postdoc pay, is \$54,840. But the new mandate puts lab leaders in a tough position, Stevens adds, because federal research grants haven’t kept up with inflation and necessities such as lab supplies are also becoming pricier. “The money has to come from somewhere,” she says.” [<<more>>](#)
